BYLAW 96-030

A BYLAW TO CLOSE AND VEST A PORTION OF SEATON ROAD AND EXCHANGE LANDS WITH THE WINFIELD EVANGELICAL MISSIONARY CHURCH (FORMERLY THE UNITED MISSIONARY CHURCH) FOR HIGHWAY PURPOSES

WHEREAS Section 573 of the Municipal Act provides that a Municipality may by bylaw stop up and close to traffic a highway or portion of it;

AND WHEREAS Section 574 of the Municipal Act provides that a Municipality may by bylaw dispose of a portion of a highway in exchange for land necessary for the purpose of improving, widening, straightening, relocating or diverting a highway;

AND WHEREAS the Council of the District of Lake Country deems it necessary and expedient to close and vest the portion of Seaton Road adjacent to and to the north of Lot A, Plan KAP51095 being 0.0987 hectares lying south of R road Plan KAP54301 as shown outlined in green on Schedule "A" the attached plan of Section 3, Township 20, Osoyoos Division Yale District which has been prepared by a B.C. Land Surveyor;

AND WHEREAS the Council of the District of Lake Country deems it necessary and expedient to exchange for the above road to be closed and disposed of that part of highway adjacent to the west of Glenmore Road being 0.0302 hectares lying within the east boundaries of Lot A, Plan KAP51095 and Lot B, Plan 6044 shown outlined in red, shown on Schedule "A", the attached plan of Section 3, Township 20, Osoyoos Division Yale District which has been prepared by a B.C. Land Surveyor;

AND WHEREAS the Council of the District of Lake Country deems this disposition and exchange to be necessary and expedient for the purpose of improving and widening a highway;

NOW THEREFORE, the Council of the District of Lake Country in open meeting assembled, enacts as follows:

1. Authority is hereby given to the District of Lake Country to close and dispose of that portion of Seaton Road adjacent to and to the north of Lot A, Plan KAP51095 being 0.0987 hectares lying south of road Plan KAP54301, shown outlined in green on Schedule "A" attached hereto in exchange for that part of highway adjacent to the west of Glenmore Road being 0.0302 hectares lying within the east boundaries of Lot A, Plan KAP51095 and Lot B, Plan 6044 as shown outlined in red on Schedule "A" attached hereto.
2. The Mayor and Clerk are hereby authorized to execute such documents and take such steps as may be necessary to carry out the purpose of this bylaw.

3. This bylaw may be known and cited as “The District of Lake Country Bylaw to Close and Vest a Portion of Seaton Road and Exchange Lands with the Winfield Evangelical Missionary Church for Highway Purposes”.
