BYLAW 805

A BYLAW TO AMEND BYLAW NOTICE ENFORCEMENT BYLAW 760, 2010

WHEREAS the Council of the District of Lake Country deems it appropriate to amend the Bylaw Notice Enforcement Bylaw 760, 2010;

NOW THEREFORE, the Council of the District of Lake Country, in open meeting assembled, enacts as follows:

1. Bylaw Notice Enforcement Bylaw 760, 2010 is hereby amended as follows:
 - (a) Deleting a portion of Schedule A, District of Lake Country Building Regulation Bylaw 709, 2011 of Bylaw 760, 2010 in its entirety, and replacing it with Schedule A, District of Lake Country Building Regulation Bylaw 709, 2011 attached hereto as Schedule A and forming a part hereof.
2. This Bylaw may be cited for all purposes as "Bylaw Notice Enforcement Bylaw Amendment Bylaw 805, 2011."

READ A THIRD TIME this 1st day of November, 2011.
