**COMPLIANCE WITH HIGHWAY ACCESS AND DRIVEWAY REGULATION BYLAW** Be sure that your application complies with all the conditions set out in Section 9 of the <u>Highways Bylaw 1189</u>, 2022. See link below for more information.

### ATTACH A SITE PLAN

Ensure that the site plan is drawn to scale and shows the following:

- Proposed driveway access location including offsets from the property lines, width, grade, elevations and surfacing. The maximum **Driveway Access** grade is 5%. See the Driveway Design & Construction Guidelines Policy 200, 2022, link below for more information.
- Existing accesses, culverts, utility poles, structures and all other features located within the highway right-of-way.
- The angle at which the access meets the highway right-of-way (between 70° and 110°)

### APPROVAL PROCESS: WHAT HAPPENS NEXT?

- Incomplete applications will not be processed.
- The applicant will be advised of any missing or required information.
- The District will determine if a culvert is required and advise the applicant.
- The applicant will be notified when the application has been reviewed and issued for construction.
- The applicant must book a post-construction access inspection with District Engineering before a permit is approved and issued.
- A \$25.00 fee is applicable for each additional inspection as required.
- An approved Driveway Access Permit may be required prior to being granted Occupancy under a building permit
