A BYLAW TO AMEND DISTRICT OF LAKE COUNTRY SOCCER SOCIETY AND SNOWLINE ENTERPRISES LTD. SPONSORSHIP AGREEMENT BYLAW 451, 2003

3. There are no further financial commitments from the Sponsor during the duration of the contract extension; and
4. All other provisions shall remain the same and be enforceable.
