**A BYLAW TO ENLARGE A LOCAL SERVICE AREA FOR THE PURPOSES OF  
PROVIDING WATER SUPPLY AND DISTRIBUTION FOR THE AREA KNOWN AS  
THE LAKE COUNTRY WATER SYSTEM**

---

WHEREAS the Council of the District of Lake Country adopted Lake Country Water Service Area Bylaw 695, 2008;

AND WHEREAS the Council of the District of Lake Country, on its own initiative, deems it necessary to enlarge the Lake Country Water Service Area;

NOW THEREFORE the Council of the District of Lake Country, in open meeting assembled enacts as follows:

1. Schedule 'A' to Lake Country Water Service Area Bylaw 695, 2008 is amended by adding the 365 properties shown outlined in bold black on Schedules 'A1' and 'A2' attached to and forming part of this bylaw.
2. This bylaw shall be cited as "Lake Country Water Service Area Amendment Bylaw 729, 2010".

READ A FIRST TIME this 16<sup>th</sup> day of February, 2010.

READ A SECOND TIME this 16<sup>th</sup> day of February, 2010.

READ A THIRD TIME this 16<sup>th</sup> day of February, 2010.

ADVERTISED on the 24<sup>th</sup> day of February and the 3<sup>rd</sup> day of March, 2010 and letters sent to property owners pursuant to the provisions of Sections 213 and 218 of the *Community Charter* on or before the 23<sup>rd</sup> day of February, 2010.

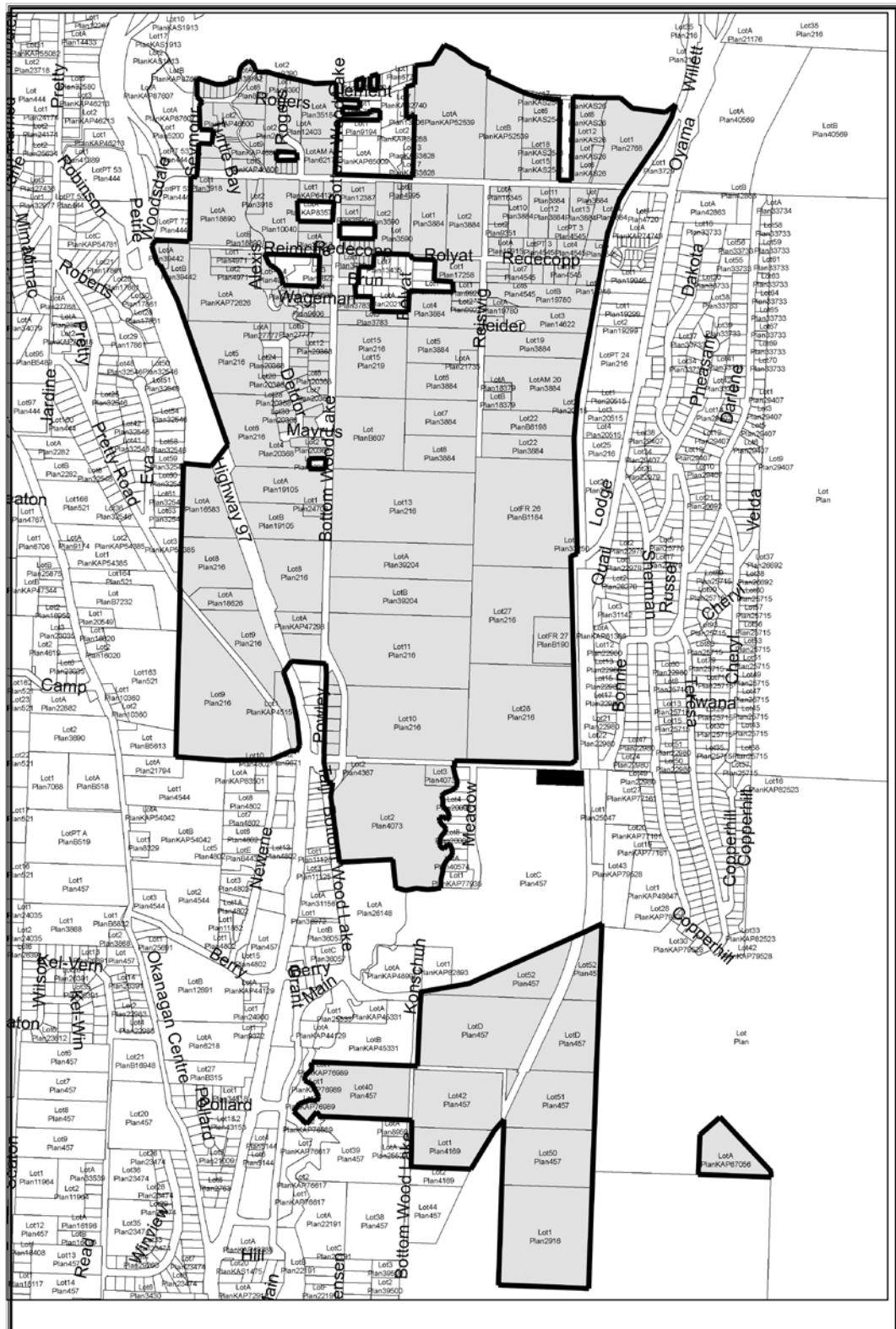

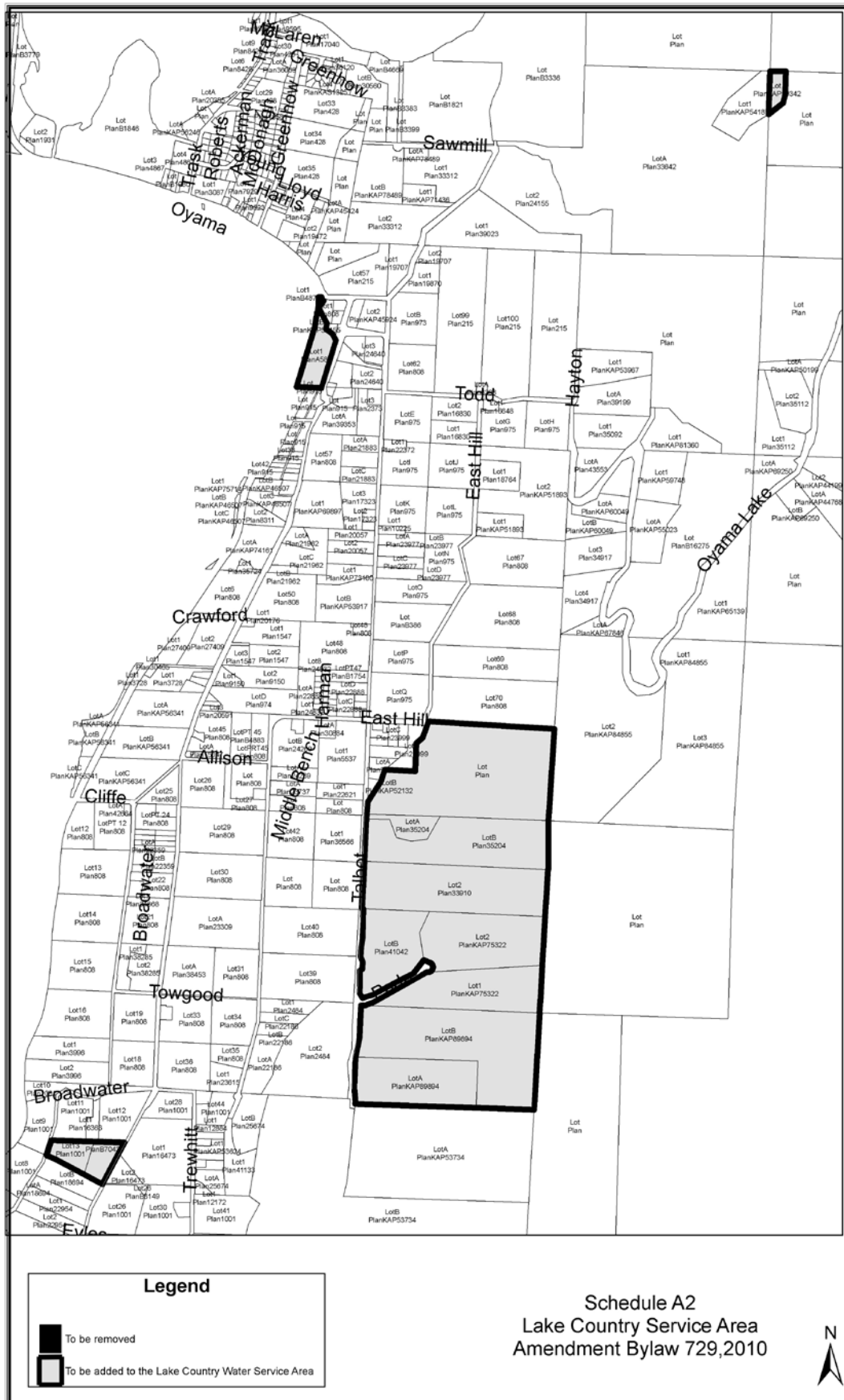


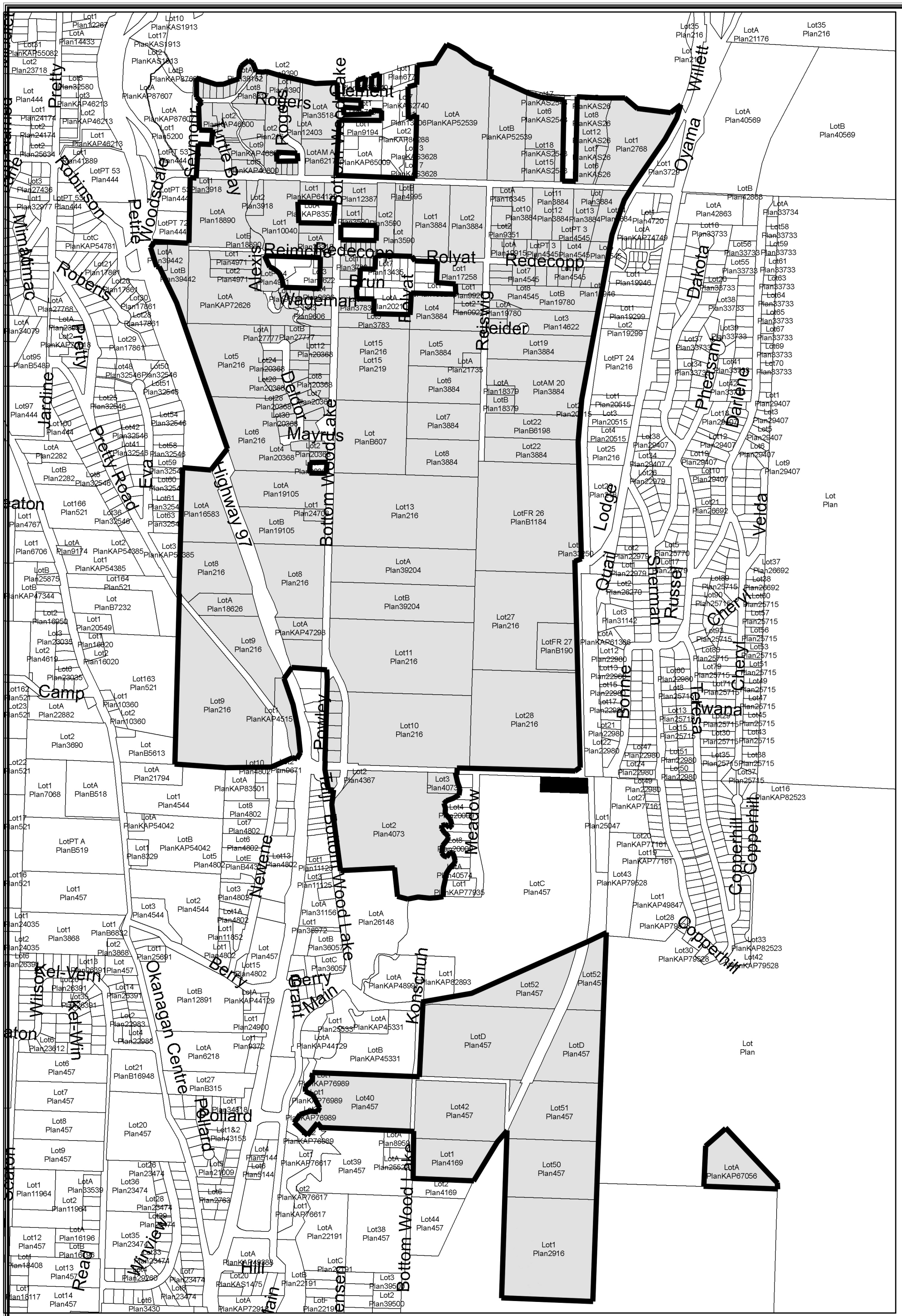

Amendment Bylaw 729,2010







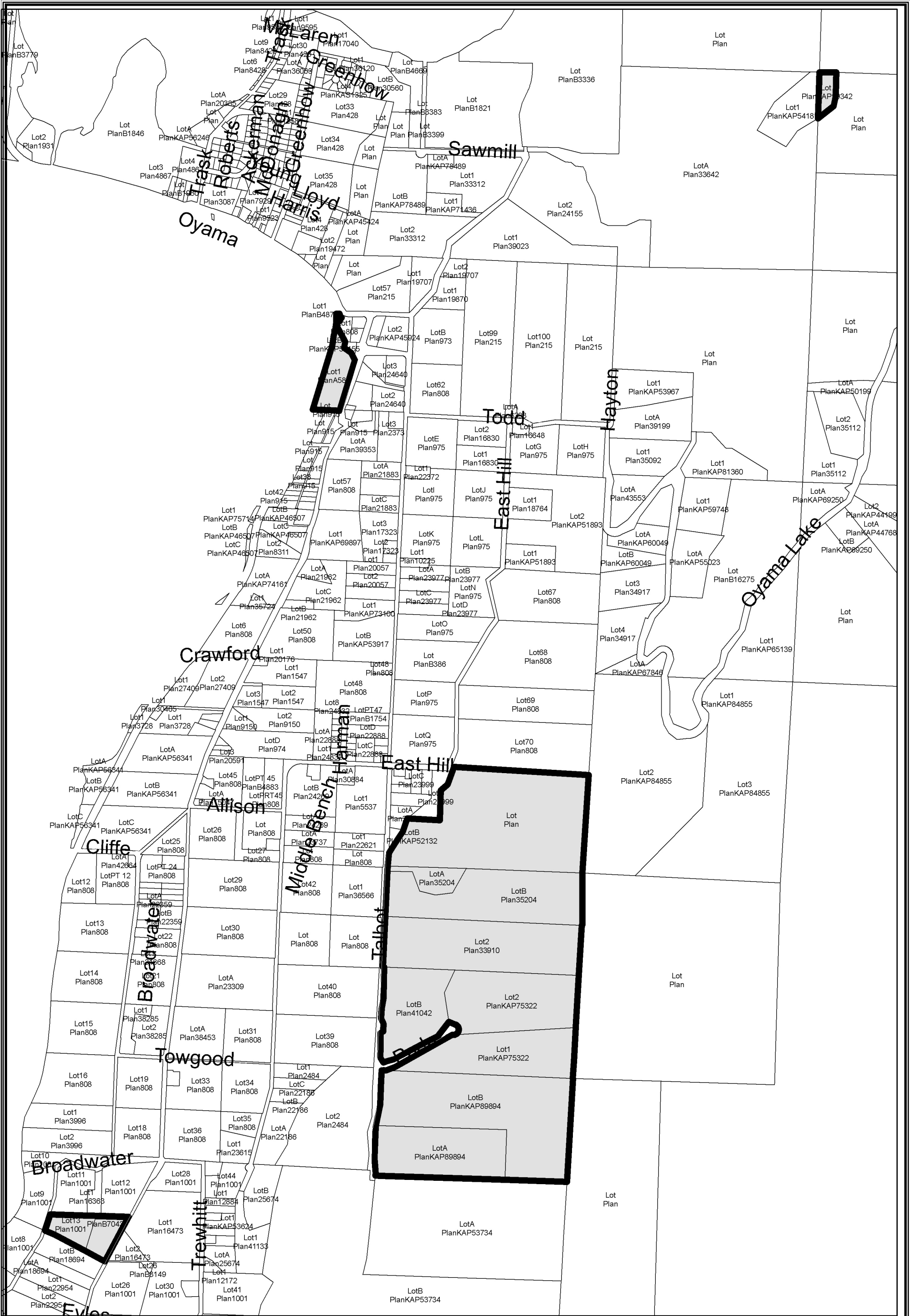
