A BYLAW TO DISCHARGE LAND USE CONTRACT NO. 221

WHEREAS by Regional District of Central Okanagan Land Use Contract Bylaw No. 221, adopted June 19, 1978, the Regional Board of the Regional District of Central Okanagan entered into Land Use Contract No. 221 dated June 20, 1978, registered in the Land Title Office, Kamloops, British Columbia under registration number N45127 (hereinafter called "Land Use Contract No. 221");

AND WHEREAS Section 930 of the Local Government Act, provides that Council may, by bylaw, discharge an existing Land Use Contract;

AND WHEREAS the Council of the District of Lake Country is desirous of discharging Land Use Contract No. 221 from Lot 3 Section 22 Township 20 ODYD Plan 5200 Except Plans 18886, H9103, and 41266;

NOW THEREFORE, the Council of the District of Lake Country, in open meeting assembled, enacts as follows:

- The Council of the District of Lake Country hereby discharges Land Use Contract No. 221 from Lot 3 Section 22 Township 20 ODYD Plan 5200 Except Plans 18886, H9103, and 41266 located at 2930 Woodsdale Road, in the District of Lake Country.
- 2. The Mayor and Municipal Clerk are hereby authorized to sign any conveyances, deeds, receipts or other documents in connection with the discharge of Land Use Contract No. 221 from Lot 3 Section 22 Township 20 ODYD Plan 5200 Except Plans 18886, H9103, and 41266 as shown in the attached Schedule "A", and affix the corporate seal of the District of Lake Country to the same.
- 3. This bylaw may be cited as "Lake Country Land Use Contract Discharge (Wood Lake Resort) Bylaw 647, 2007".
