BYLAW 775

A BYLAW TO AMEND MUNICIPAL TICKET INFORMATION BYLAW 753, 2010

WHEREAS the Council of the District of Lake Country deems it appropriate to amend the Municipal Ticket Information Bylaw 753, 2010;

NOW THEREFORE, the Council of the District of Lake Country, in open meeting assembled, enacts as follows:

1. Municipal Ticket Information Bylaw 753, 2010 is hereby amended as follows:
 - (a) Amend the portion of Schedule 1 to remove "District of Lake Country Building Regulation Bylaw 435, 2002" and replace with "District of Lake Country Building Regulation Bylaw 709, 2011".
 - (b) Delete Schedule 3 of Municipal Ticket Information Bylaw 753, 2010 in its entirety, and replace with Schedule 3 attached hereto as Schedule A and forming a part hereof.
2. This Bylaw may be cited for all purposes as "Municipal Ticket Information Amendment Bylaw 775, 2011."
