A BYLAW TO AMEND MUNICIPAL TICKET INFORMATION BYLAW 753, 2010

WHEREAS the Council of the District of Lake Country deems it appropriate to amend the Municipal Ticket Information Bylaw 753, 2010;

NOW THEREFORE, the Council of the District of Lake Country, in open meeting assembled, enacts as follows:

1. Municipal Ticket Information Bylaw 753, 2010 is hereby amended as follows:
 - (a) Delete Schedule 3 of Municipal Ticket Information Bylaw 753, 2010 in its entirety, and replace with Schedule 3 attached hereto as Schedule A and forming a part hereof.
2. This Bylaw may be cited for all purposes as "Municipal Ticket Information Amendment Bylaw 804, 2011."

READ A THIRD TIME this 1st day of November, 2011.
