**A BYLAW TO AMEND MUNICIPAL TICKET INFORMATION BYLAW 753, 2010**

---

NOW THEREFORE, the Council of the District of Lake Country, in open meeting assembled, enacts as follows:

1. Municipal Ticket Information Bylaw 753, 2010 is hereby amended as follows:
  - 1.1. Schedule 1 [Designated Bylaws and Designated Bylaw Enforcement Officers] is hereby deleted and replaced with Schedule A attached hereto and forming part of this bylaw.
  - 1.2. Schedule B entitled Schedule 18 [Smoking Regulation Bylaw 954, 2016] attached hereto and forming part of this bylaw as is hereby added as an additional to Municipal Ticket Information Bylaw 753, 2010.
  - 1.3. The text "Schedules 2 through 17" in items 3, 4 and 4 i) is hereby deleted and replaced with the text "Schedules 2 through 18".
2. This Bylaw may be cited for all purposes as "Municipal Ticket Information Amendment (Smoking) Bylaw 955, 2016."
