RECREATION FACILITIES AND PARKS FACILITY RENTAL FEES SCHEDULE A - CREEKSIDE THEATRE

General Regulations:

- 1. Day 8:00 a.m. to 4:00 p.m.;
- 2. Evening 4:00 p.m. to 12:00 midnight;
- 3. After hours 12:00 midnight to 8:00 a.m.;
- 4. If 50% of blocked time is after 4:00 p.m., evening rates will apply to entire booking;
- 5. Deposit of 50% of rental fee is due at time of booking;
- 6. All rates subject to GST/HST as applicable;
- 7. Renters are responsible for applicable performance and royalty fees such as SOCAN;
- 8. Non-profit rates apply only to registered non-profit societies;
- 9. Renters are responsible to leave the facility as they had received it except for regular custodial work such as floor washing or sweeping;
- 10. Rehearsal time may be cancelled with seven days' notice if a performance is booked in the theatre;
- 11. No theatre equipment may be used (lighting, sound or rigging) without the presence of a qualified technician;
- 12. House technician required for all "performances or main events";
- 13. All Performance/Main Event rates include the services of a House Technician unless otherwise specified;
- 14. All rates and fees are negotiable by the theatre manager;
- 15. All payment of fees is due prior to commencement of bookings unless the Director has made other arrangement with renter;
- 16. Special booking rates may be determined by the Director;
- 17. Performance or Event 4-hour minimum includes 2 hours of setup/takedown time at no extra charge unless technician is required.
