## **BYLAW 377**

## A BYLAW TO CLOSE A PORTION OF BEAVER LAKE ROAD AND EXCHANGE LANDS WITH LAKE COUNTRY INVESTMENTS INC. FOR HIGHWAY PURPOSES

WHEREAS Section 525.3 of the Local Government Act provides that a Municipality may, by bylaw, dispose of a portion of a highway in exchange for land necessary for the purpose of improving, widening, straightening, relocating or diverting a highway;

AND WHEREAS the Council of the District of Lake Country deems it necessary and expedient to dispose of that portion of highway shown as Parcel '1', in exchange for certain lands owned by Lake Country Investments Inc. shown as Parcel '2', on the attached plan of Road, Lot 1, Plan KAP 68714, Section 10, Township 20, Osoyoos Division Yale District, which plan was prepared by T. E. Ferguson Land Surveying Ltd., B.C.L.S. and dated the 25th day of June, 2001 and that such disposition and exchange are necessary and expedient for the purpose of relocating and establishing a highway.

AND WHEREAS before adopting this bylaw, the Council has caused public notice to be given by advertisement once each week for two consecutive weeks in a newspaper published and circulating in the District of Lake Country.

NOW THEREFORE, the Council of the District of Lake Country in open meeting assembled, enacts as follows:

- 1. Authority is hereby given to the District of Lake Country to dispose of Parcel '1', shown outlined and labeled as Closed Road, in exchange for Parcel '2' shown outlined and labeled as Road, on the attached plan prepared by T. E. Ferguson Land Surveying Ltd., B.C.L.S. dated the 25th day of June, 2001.
- 2. The Mayor and Clerk are hereby authorized to execute such documents and legal survey plans, and take such steps as may be necessary to carry out the purpose of this bylaw.
- 3. This bylaw may be cited as "District of Lake Country Road Closure and Exchange Bylaw 377, 2001".
