

## DISTRICT OF LAKE COUNTRY

### BYLAW 465

---

#### **A BYLAW TO CLOSE A PORTION OF BARKLEY ROAD AND EXCHANGE LANDS WITH “JACKSON” PROPERTY FOR HIGHWAY PURPOSES**

---

WHEREAS Section 525.3 of the Local Government Act provides that a Municipality may, by bylaw, dispose of a portion of a highway in exchange for land necessary for the purpose of improving, widening, straightening, relocating or diverting a highway;

AND WHEREAS the Council of the District of Lake Country deems it necessary and expedient to dispose of that portion of highway shown as Parcel ‘2’ and Parcel ‘4’, in exchange for certain lands shown as Parcel ‘1’, Parcel ‘3’, and Parcel ‘5’ owned by Jamie Jackson shown as Lot 13, Section 32, Township 20, Osoyoos Division Yale District, Plan 525, which plan was prepared by William E. Maddox, B.C. Land Surveyor and dated the 09<sup>th</sup> day of September, 2003 and that such disposition and exchange are necessary and expedient for the purpose of relocating and establishing a highway.

AND WHEREAS before adopting this bylaw, the Council has caused public notice to be given by advertisement once each week for two consecutive weeks in a newspaper published and circulating in the District of Lake Country.

NOW THEREFORE, the Council of the District of Lake Country in open meeting assembled, enacts as follows:

1. Authority is hereby given to the District of Lake Country to dispose of Parcel ‘2’ and Parcel ‘4’, shown outlined and labeled as Closed Road, in exchange for Parcel ‘1’, Parcel ‘3’, and Parcel ‘5’ shown outlined and labeled as Road, on the attached plan prepared by William E. Maddox, B.C. Land Surveyor dated the 09<sup>th</sup> day of September, 2003.
2. The Mayor and Clerk are hereby authorized to execute such documents and legal survey plans, and take such steps as may be necessary to carry out the purpose of this bylaw.
3. This bylaw may be cited as “District of Lake Country Road Closure and Exchange Bylaw 465, 2003”.

READ A SECOND TIME this 14<sup>th</sup> day of October, 2003.

READ A THIRD TIME this 14<sup>th</sup> day of October, 2003.

ADVERTISED on October 28<sup>th</sup>, 2003 and November 5<sup>th</sup>, 2003.

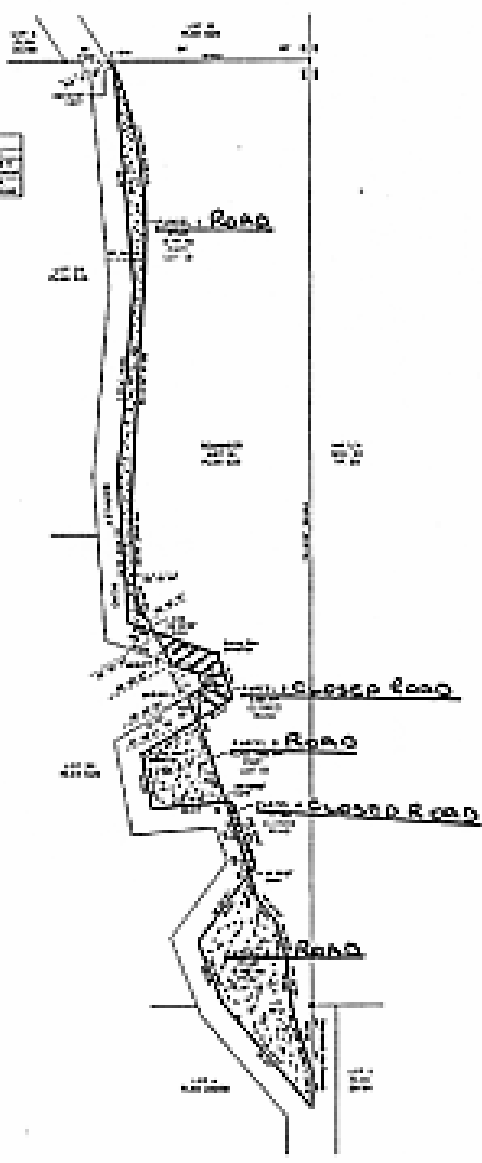
