#### **BYLAW 559**

## A BYLAW TO CLOSE A PORTION OF 7<sup>TH</sup> STREET TO TRAFFIC, REMOVE ITS DEDICATION AS A HIGHWAY, AND EXCHANGE THE CLOSED PORTION FOR LANDS OWNED BY THE ADJACENT PROPERTY OWNERS

WHEREAS pursuant to section 40 of the Community Charter, Council may permanently close a highway (road) that is vested in the municipality and may remove highway dedication;

AND WHEREAS Council deems it desirable to close a portion of 7<sup>th</sup> Street dedicated on Plan 454, Section 17, Township 20, ODYD, located within the boundaries of the District of Lake Country and to remove its dedication as a highway;

AND WHEREAS Council deems it desirable to dispose of the closed portion of 7<sup>th</sup> street by transfer of title to the adjacent land owner for the purpose of consolidation with the adjacent lands and to accept as payment, an equal portion of the subject adjacent lands currently known as Lot A, Plan 41468, Sec. 17, TP 20, ODYD for the purposes of road, all as shown on the attached sketch.

NOW THEREFORE the Council of the District of Lake Country, in open meeting assembled, enacts as follows:

- 1. The District of Lake Country hereby authorizes the closure to traffic of that portion of highway of approximately 585 m2 and outlined in bold black on a reference plan prepared by Douglas A. Goddard, B.C.L.S. on the 15<sup>th</sup> day of August, 2005, a reduced copy of which is attached to this bylaw as Schedule "A";
- 2. The District of Lake Country hereby authorizes the removal of highway dedication of the portion of highway of approximately 585 m2 and outlined in bold black on a reference plan prepared by Douglas A. Goddard, B.C.L.S. on the 15<sup>th</sup> day of August, 2005, a reduced copy of which is attached to this bylaw as Schedule "A";
- 3. The District of Lake Country hereby authorizes the disposal of that section of highway that has been closed by this bylaw and described in section 1, to Steve and Gael Stairs, being the adjacent land owner; AND FURTHER, as payment for the closed highway portion, authorizes the dedication of a portion of land owned by Steve and Gael Stairs of approximately 585 m2 and shown as "road" on a reference plan prepared by Douglas A. Goddard, B.C.L.S. on the 15<sup>th</sup> day of August, 2005, a reduced copy of which is attached to this bylaw as Schedule "B";
- 4. The Clerk and the Mayor are hereby authorized as signatories on all legal plans, conveyances and agreements that are necessary for the closure, removal of dedication, disposal of the closed road to Steve and Gael Stairs and dedication of a portion of land currently known as Lot A, Plan 41468, Sec. 17, TP 20, ODYD as "road", all as outlined in this bylaw and as shown on the sketch attached to this bylaw as Schedule "B";
- 5. This bylaw may be cited as "Road Closure and Removal of Highway Dedication Bylaw 559, 2006".

READ A FIRST TIME this 24<sup>th</sup> day of January, 2006.

Pursuant to section 94 (1) of the Community Charter, Public Notice was posted and printed in the February 8<sup>th</sup>, 2006 and February 15<sup>th</sup>, 2006 editions of the local newspaper.

READ A SECOND TIME this 21<sup>st</sup> day of February, 2006. READ A THIRD TIME this 21<sup>st</sup> day of February, 2006.


