A BYLAW TO ESTABLISH A PARCEL TAX FOR PROPERTIES WITHIN THE DISTRICT OF LAKE COUNTRY CAPABLE OF BEING SERVED BY THE MUNICIPAL SEWER SYSTEM

Deleted & replaced by Bylaw 918, 2015 WHEREAS the Community Charter authorizes the District to impose a parcel tax based on the single amount per parcel on the owners of land or real property capable of being drained into a sewer, whether or not the land or real property is connected to the sewer, for the opportunity to use the sewer;

AND WHEREAS the Community Charter authorizes a municipality to impose a parcel tax based on a single amount per parcel or a frontage tax based on taxable frontage or taxable area.

AND WHEREAS the Council of the District of Lake Country has established a sewer system by District of Lake Country Sewer System Establishment Bylaw 98-181, and deems it necessary to levy a parcel tax against all real property capable of being connected into a municipal sewer system whether or not the land or real property is connected to the sewer, for the opportunity to use the sewer;

NOW THEREFORE the Council of the District of Lake Country in open meeting assembled, enacts as follows:

 A parcel tax shall be and is hereby imposed and levied upon the owners of land or real property within the District of Lake Country (hereinafter called the "District") capable of being served by the District's sewer system.

The parcel tax shall be levied in each year on each parcel of land aforementioned and the amount of such parcel tax shall be Two Hundred and Seventy Five Dollars (\$275).

- The parcel tax shall be in force until the complete discharge and satisfaction by the
 District of all obligations presently incurred and to be incurred in respect of provision of
 the District's sewer system.
