BYLAW 98-181

A BYLAW TO ESTABLISH A SYSTEM OF SEWERAGE WORKS FOR THE COLLECTION, CONVEYANCE AND DISPOSAL OF SEWAGE WITHIN THE DISTRICT OF LAKE COUNTRY

WHEREAS the Ministry of Environment has approved the Wastewater Management Plan for Electoral Area "A" of the Regional District of Central Okanagan;

AND WHEREAS the Wastewater Management Plan identifies the establishment of a community sewerage system for the collection, treatment and disposal of sewerage;

AND WHEREAS the Wastewater Management Plan identifies the implementation of a program for enhanced on-site disposal, including regulatory controls;

AND WHEREAS Regional District of Central Okanagan waived the right of assent of the electorate in accordance with the Waste Management Act and established a local service area for sewer known as "Regional District of Central Okanagan Winfield Sewer System Local Service Area Establishment Bylaw No. 519, 1992";

AND WHEREAS Electoral Area "A" of the Regional District of Central Okanagan was incorporated into the District of Lake Country with all bylaws and other authorities transferring to the municipality by Letters Patent dated the 23rd day of February, 1995;

AND WHEREAS, pursuant to the provisions of Section 574 of the Municipal Act, a municipality may, by bylaw, provide for the establishment of a system of sewerage works for the collection, conveyance and disposal of sewage;

AND WHEREAS the Council of the District of Lake Country deems it necessary to re-establish a system of sewerage works for the collection, conveyance and disposal of sewage within the boundaries of the District of Lake Country;

NOW THEREFORE the Council of the District of Lake Country in open meeting assembled, enacts as follows:

- 1. The District of Lake Country hereby establishes a District of Lake Country Sewer System to properties within the boundaries of the municipality described in District of Lake Country Letters Patent.
- 2. The sewer system may consist of any of the following:

a) a system for the collection, treatment and disposal of sewerage centralized in the Winfield area;

- b) satellite systems for the collection, treatment and disposal of sewerage in Carr's Landing, Okanagan Centre and Oyama;
- c) enhanced on-site septic disposal systems or conventional on-site septic disposal systems, pump-out of septic systems with disposal at the centralized system, and may include approval of plans, authority for inspection and regular maintenance programs.
- 3. Council may exercise any of the powers and authorities pursuant to Section 574 of the Municipal Act and amendments thereto.
- 4. The costs for the service described in Section 2 herein shall be recovered by the imposition of user fees and other charges which may be fixed by separate bylaws for the purpose of recovering these costs.
- 5. "Regional District of Central Okanagan Winfield Sewer System Local Service Area Establishment Bylaw No. 519, 1992" is hereby repealed in its entirety.

6. If any section, subsection, paragraph, subparagraph or phrase of this bylaw is for any reason declared invalid by a Court of competent jurisdiction, the decision shall not affect the validity of the remaining portions of this bylaw.

- 7. This bylaw shall come into full force and effect upon the date of its adoption.
- 8. This bylaw may be cited as "District of Lake Country Sewer System Establishment Bylaw 98-181".
