**BYLAW 876**

**A BYLAW TO EXEMPT CERTAIN PROPERTY IN THE  
DISTRICT OF LAKE COUNTRY FROM TAXATION**

---

WHEREAS the Council of the District of Lake Country may by bylaw, under certain conditions, exempt land or improvements, or both, from taxation;

NOW THEREFORE, the Council of the District of Lake Country, in open meeting assembled, enacts as follows:

1. Those certain parcels or tracts of land and improvements, situated, lying and being in the District of Lake Country, as described in Schedule "A", "B" & "C" attached hereto and forming part of this bylaw, shall be exempt from taxation.
2. This bylaw shall commence at the beginning of the 2014 taxation year, being January 1, 2014 and cease at the end of the 2018 tax year, being December 31, 2018.
3. This bylaw may be cited as "Tax Exemption Bylaw 876, 2013".

READ A SECOND TIME this 3<sup>rd</sup> day of September, 2013.  
READ A THIRD TIME this 3<sup>rd</sup> day of September, 2013.
