**A BYLAW TO AMEND ZONING BYLAW 561, 2007**

---

The Council of the District of Lake Country, in open meeting assembled, enacts as follows:

1. District of Lake Country Zoning Bylaw 561, 2007 section 16.3 C9 – Tourist Commercial zone subsection 16.3.2 Principal Uses is hereby amended by adding “(k) retail stores, convenience on that 1.2 ha. portion of That Part of the Fractional South East ¼ of Section 11 Outlined Red on Plan B3779; Township 14 ODYD Except: (1) Colored Red on Plan A421 (2) Plans 8939 and 39746 shown as Area ‘B’ in Schedule A attached hereto to; and
2. District of Lake Country Zoning Bylaw 561, 2007 section 16.3 C9 – Tourist Commercial zone subsection 16.3.3 Secondary Uses is hereby amended by adding “(k) gas bar and marine fuel facility on that 1.2 ha. portion of That Part of the Fractional South East ¼ of Section 11 Outlined Red on Plan B3779; Township 14 ODYD Except: (1) Colored Red on Plan A421 (2) Plans 8939 and 39746 shown as Area ‘B’ in Schedule A attached hereto to.
3. This bylaw may be cited as “Zoning Amendment (Z2018-009) Bylaw 1139, 2021”.

READ A FIRST TIME this 2<sup>nd</sup> day of March 2021.

READ A SECOND TIME this 2<sup>nd</sup> day of March 2021.

ADVERTISED on the 29<sup>th</sup> day of April and 6<sup>th</sup> day of May, 2021 and a Public Hearing held pursuant to the provisions of Section 464 of the *Local Government Act* on the 11<sup>th</sup> day of May, 2021.

READ A THIRD TIME this 1<sup>st</sup> day of June, 2021.

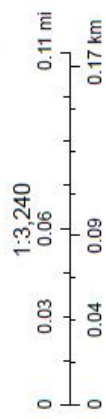
